#### How to use this Framework

Step 1 - Complete the Customer Access Agreement (online at espo.org)

**Step 2 -** Establish whether your needs can be met by a supplier(s) on the framework or whether you need to conduct a further competition.

If assessing that the vehicle telematics products and services requirements can be met by a single supplier then an order can be placed directly via the nominated supplier. The relevant supplier contact details that would be necessary for use are accessible by contacting ESPO directly.

The default option however would be to run a further competition as this will ensure the best products, services and price based on your specification. When running a further competition, the following contract award criteria should be considered –

Quality - added value, innovation, social value, approach to the delivery of the products and services, implementation and use of supply chain partners. Other criteria may include cost-effectiveness, after sales service, running costs, delivery date and the period for completion.

Price – installation, integration, monthly fees, software upgrades, maintenance, training, data reporting and equipment disposal.

If you decide you need to conduct a further competition, this should be arranged by seeking quotations from **all** of the suppliers on the framework that are able to meet the requirements in your particular location.
