Product Declaration - Safety Data Sheets (SDS)

Dear Valued Customer:

The product forms listed above meet the definition/are classified as Cosmetic products under Regulation (EC) No 1223/2009 of the European Parliament and of the Council of 30 November 2009 on cosmetic products (Article 2 (1(a)) which replaced Council Directive 76/768/EEC of 27 July 1976 on the approximation of the laws of the Member States relating to cosmetic products.

The requirements to provide a Safety Data Sheet arise from Article 31 “Requirements for safety data sheets” of TITLE IV “INFORMATION IN THE SUPPLY CHAIN” of the REGULATION (EC) No 1907/2006 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 18 December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH), establishing a European Chemicals Agency, amending Directive 1999/45/EC and repealing Council Regulation (EEC) No 793/93 and Commission Regulation (EC) No 1488/94 as well as Council Directive 76/769/EEC and Commission Directives 91/155/EEC, 93/67/EEC, 93/105/EC and 2000/21/EC – in short “REACH Regulation”. At the same time, the provisions of Title IV of REACH Regulation do NOT apply, inter alia, to Cosmetic products in the finished state, intended for the final user (Article 2 (6(b))). Furthermore, Cosmetic products are outside of the scope of the REGULATION (EC) No 1272/2008 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 16 December 2008 on classification, labeling, and packaging of substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006 (Article 1(5(c))).
