This framework can be employed through a direct call-off process with your chosen service provider, adhering to the terms detailed in the user guide. Alternatively, you can engage in a further competition among all eligible service providers capable of fulfilling your specific requirements.

There are three lots within the framework:

- Lot 1 Portable Appliance Testing (PAT)
- Lot 2 Fixed Installation Testing (FIT)
- Lot 3 Electrical Testing of Street Lighting and Street Furniture

Who can use this Framework?

How to use this Framework

Step 1 - Complete the online Access and Confidentiality Agreement which can be found at Stage 2 of the 'Get Started' section on the ESPO website at the following link: <u>Electrical Testing Services (espo.org)</u>.

Step 2 - Review the User Guide to establish whether your needs can be met by a single supplier or whether you need to conduct a Further Competition. Section 5 contains more information on how to place an order. Typically smaller, more straightforward requirements can be met by one supplier, larger, more complex requirements will require a Further Competition to achieve the best supply solution.

If you decide that a single supplier can meet your requirements based on the pricing and/or other information provided in the User Guide, simply place an order with that supplier. A template order form is available for you to use at Appendix 2 of the User Guide.

If you decide you need to conduct a Further Competition you may do so by seeking quotations from **all** the suppliers that are able to meet your requirements in your particular location. More specific details on how to conduct a further competition can be found in Section 5 of the User Guide.

Step 3 - Complete the Confirmation of Award Form (online at espo.org) and send it to ESPO.

This should be completed whether you have placed a call-off order or conducted a further competition as this will allow ESPO to monitor the spend being put through the suppliers under the framework agreement.
